Explanation of Responses:

- (1) The 3,000 shares were awarded to reporting person under the 2003 Incentive Plan. The shares vest February 2, 2014. The award is exempt from Section 16(b) under Rule 16 (b) -3.
- (2) These shares are owned by a corporation in which reporting person is an officer and shareholder. Represents all shares owned by the corporation.
- (3) These shares are owned by a limited liability company (formerly a general partnership) in which reporting person owns a 1/6 interest. The other members of the limited liability company are reporting person's siblings. Represents all shares owned by the company.
- (4) Represents shares of the issuer contributed by reporting person's parents to a limited liability company on June 16, 2008 (as previously reported). Reporting person is managing member of the company. On November 20, 2008, a gift was made to reporting person of one-sixth of the membership interests of the company. The 23,193 shares are all of the shares of issuer owned by the limited liability company.
