- (3) Includes shares owned by Gould General LLC, of which reporting person is sole member.
- (4) Reporting person is an officer and director of One Liberty Properties, Inc., the corporation which owns these shares..
- (5) Reporting person is a partner in 130 Store Company, which owns these shares.
- (6) Reporting person disclaims beneficial interest in these shares. Reporting person's spouse is a director of the Gould Shenfeld Family Foundation which owns 23,469 shares of issuer.
- (7) Reporting person is grantor of the Gould Family Trust, which owns these shares.
- (8) Reporting person is a trustee of BRT Realty Trust Pension Trust, which owns these shares.
- (9) Reporting person is a trustee of, and participant in, the pension and profit sharing trusts of REIT Management Corp., which owns these shares.
- (10) Reporting person is a director of the Gould Shenfeld Family Foundation.
- (11) Reporting person is custodian of these shares for a minor. Reporting person disclaims any benefiical interest in these shares.
- (12) Represents shares owned by Gould Investors L.P. Reporting person is sole shareholder and an executive officer of the corporate managing general partner of Gould Investors L.P. and sole member of a limited liability company which is the other general partner of Gould Investors L.P. Reporting person also holds limited partnership interests in Gould Investors L.P. both directly and indirectly. These shares represent all shares of issuer owned by Gould Investors L.P.
