Each such unit is granted in tandem with a cash settled dividend equivalent right entitling the holder, to the extent such unit vests, to the cash dividends paid on the shares underlying such units from the grant date through March 31, 2021.
- 3. The restricted stock units vest on March 31, 2021, subject to satisfaction of applicable continued service and performance conditions.
